BYLAW 12-2019

A BYLAW TO AMEND BYLAW 37-2017

AMENDMENT NO. 2.

AS a clarification is required to the provisions creating an offence for failing to possess a dog licence in the *Responsible Dog Ownership Bylaw*, 37-2017;

Council Enacts:

- 1 Bylaw 37-2017 is amended by this bylaw
- 2 Clause 3(d) is deleted and replaced by the following:

"at large" means a dog that is not restrained by a leash or otherwise under the physical control of a person, and that is at a location other than:

- (i) the owner's property;
- (ii) inside the boundaries of an off-leash area;
- (iii) on private property with the consent of the owner of that private property;
- (iv) a dog grooming premises, during dog grooming; or
- (v) a location that is hosting a dog sporting event, dog training event, or dog show event;
- 3 Clause 3(gg)(v) is deleted and replaced by the following:
 - a person to whom a licence was issued for a dog, under this or any other bylaw or enactment; or
- 4 Section 8.1, as follows, is added after section 8:
 - 8.1 An owner of a dog must have a valid and subsisting dog licence for that dog.
- Section 23 is amended by adding the words ", and the applicant must provide," after the words "The Chief Commissioner may request from an over-limit permit applicant..."
- 6 Section 24 is deleted and replaced by the following:
 - The Chief Commissioner may decline to issue an over-limit permit and may impose conditions and restrictions on an over-limit permit, and an owner must comply with any conditions and restrictions imposed.

7 Section 31 is deleted and replaced by the following:

An owner who does not immediately remove defecation left by that owner's dog, at a location other than the owner's property, is guilty of an offence.

8 Section 33 is deleted and replaced by the following:

A person who, without the consent of the owner, releases a dog from a secure enclosure is guilty of an offence.

- 9 Clause 56(c) is deleted and replaced by the following:
 must keep the dangerous dog on a leash that is no longer than two (2) metres in length
 when the dangerous dog is not in a secure enclosure;
- 10 Clause 56(d) is amended by adding the word "must" before the word "securely".
- 11 Section 58 is deleted and replaced by the following:

The Chief Commissioner may impose conditions and restrictions on a dangerous dog licence and an owner must comply with any conditions and restrictions imposed.

12 Schedule "A" is deleted in its entirety and replaced by Schedule "A" to this bylaw.
