In consideration of the benefits to be derived by me/us from the performance of the following work on the sewer service line:

I/We, the owner(s) or occupier(s) or agent(s) of the owner(s) or occupier(s) of the land, hereby grant permission to Strathcona County, its employees, servants, agents and contractors ("the County"), to enter upon the land municipally known as

Alberta, ("the land"), and to use such equipment and materials as the County considers necessary to perform the work.

I/We understand the County is responsible for sewer service lines located on or under public property and that the owner's obligation is with respect to sewer service line on or under private property. In exchange for the County performing this work I/we agree to the following:

I/We understand that by signing this authorization I am representing to the County that I/we am/are the owner or occupant or authorized agent of the owner or occupant of the land and that I/we have the authority to give this authorization. If any of these things are not true, then I/we am/are personally responsible to the County for any damages that it suffers because of this misrepresentation, including legal costs.

If the obstruction (a) is determined to be located on private property and is not directly or indirectly attributable to a condition created by County owned infrastructure or (b) is on the County's property but is due to the owner(s) or occupier(s)' occupation of the land, I/we will pay Strathcona County a fee of

The County accepts responsibility for the negligence of the County, its agents, contractors or employees in providing service under this contract. I/we waive any right to sue or bring any other kinds of claim against the County except where the County, its agents, contractors or employees are negligent.

I/we agree to hold harmless and indemnify the County from any and all liability for any property damage, personal injury to any third party or other financial loss or expense, including legal expenses and costs (on a solicitor and his own client basis), which arise out of or incidental to anything done or not done in the performance of the said work, except for the negligence of the County.
