
General Notes:

- Vehicles in the urban area must be parked in an approved hard surface parking space and may not be parked on grass, gravel, or any other soft landscape material.
- Parking of heavy vehicles and/or mobile equipment in urban residential areas shall be located indoors or outdoors in a location which is generally not visible from public roads or adjacent properties. Parking of heavy vehicles is not permitted in a front yard.
- A vehicle may be parked in a rear or side yard (not flanking a road) provided the parking area is accessed from the approved driveway.
- 4. Vehicles parked on an approved parking space must be contained entirely within the property boundaries and may not extend into the right-of-way.

1: Interior Lot (Detached Garage)



- Notes: 1. No vehicle (including RVs, trailers, etc.) can be parked in the front yard or in front of established building lines other than on an approved parking space.
 - 2. As illustrated above, a parking space in the front yard is permitted provided it is contiguous with the driveway leading to the detached garage and does not exceed the width of 6.0m in the front yard.
 - 3. Parking may be accommodated in the side and rear yard as illustrated above provided the parking area is accessed through the approved driveway.





2: Interior Lot (No Garage)




Notes: 1. No vehicle (including RVs, trailers, etc.) can be parked in the front yard or in front of established building lines other than on an approved parking space.

- In the illustration above, a parking space in the front yard is permitted provided it does not exceed the maximum width of 6.0m in the front yard
- 3. Parking may be accommodated in the side and rear yard as illustrated above provided the parking area is accessed through the approved driveway.
- 4. Should have a min. 150mm (6") unobstructed width for the swale within the common property line.

3: Interior Lot (Front Attached Garage)


