MESSAGE FROM THE DIRECTOR



Strathcona County Transit provides access to many aspects of the community including places of employment, social activities, medical needs, shopping, education and government destinations. In addition, Transit enhances economic and environmental sustainability by improving labour mobility and reducing automobile use. Our staff is a customer focused team continually looking for ways to improve safety, the customer's experience, and service reliability.

COVID-19 has impacted Transit significantly and will continue to impact Transit for years to come. Revenues have decreased (working from home will continue for many passengers), cleaning measures have changed (introduction of electrostatic sprayers), and bus infrastructure is different (bus barriers and

air purificiation systems will be mandatory going forward). Transit has worked tirelessly to ensure our buses and staff are as safe as possible and will continue to do so. In addition, our team is empowered to look for innovative ways to make Transit more safe, efficient and flexible. Current Transit projects include:

- Being a partner in the regional Arc (formerly Smart Fare) project
- Completing Investing in Canada Infrastructure Program projects: permanent operator shields on conventional buses, enhanced air purification on entire fleet, and real-time display technology in the transit terminals
- Implementing On Demand Transit, a shared-ride demand-responsive service pilot in 2022 to improve the efficiency of service
- Partnering with Edmonton in the Alberta Zero Emission Hydrogen Transit
 (AZEHT) project funded through Emmissions Reductions Alberta (ERA) that will
 demonstrate two hydrogen fuel cell electric buses (FCEB) to be used in road
 trials that also includes the active participation of Calgary and Banff/Bow Valley

Over the next business cycle, we will continue to focus on building a strong community that supports the diverse needs of residents. Affordable services are an important part of an efficient and effective multi-modal transportation network. Further, Transit will look to improve its service delivery through new initiatives from the Transit Master Plan that was approved in 2019. By ensuring our transit fleet keeps passengers moving in a safe and efficient manner and participating on regional projects, Transit continues to contribute to the strategic direction and priorities of Strathcona County, helping to make Strathcona County Canada's most livable community.

DEPARTMENT OVERVIEW

Strathcona County Transit is a service-oriented department focused on enhancing the mobility of the community. Transit's four core functions are:

- Inter-municipal transit
- Local transit

- Mobility bus
- Special events

To deliver our core functions, we currently:

- Have 52 standard buses, 24 double decker buses, and 15 mobility buses
- Maintain a Transit fleet that is 100% accessible
- Manage two bus terminals: Bethel Transit Terminal and Ordze Transit Centre
- Employ approximately 165 experienced staff, including 100 full-time and hourly Transit Operators
- Continue to invest in our front-line staff through annual customer service and driver training

Transit's Master Plan was approved in February 2019 and will drive transit services at Strathcona County for the next seven years. This Master Plan, along with the other projects Strathcona County Transit is involved in, will ensure that sustainable mobility services for the community are a priority.

DEPARTMENT CORE BUSINESS FUNCTIONS AND PROGRAMS (SUMMARY OF OPERATIONAL PLANS)

INTER-MUNICIPAL TRANSIT

Inter-municipal transit services and park and ride provide access to major regional destinations, such as downtown Edmonton and the University of Alberta. Through fare integration agreements, riders can transfer from Strathcona County buses to Edmonton or St. Albert transit systems with minimal cost, to access even more destinations.

The Priority Based Budgeting programs under the Inter-Municipal Transit core function are:

- Inter-municipal Transit Peak Service
- Inter-municipal Transit Midday Service
- Inter-municipal Transit Evening Service
- Inter-municipal Transit Weekend Service

LOCAL TRANSIT

Local transit services are provided within Sherwood Park through a hub and spoke network with the Bethel Transit Terminal as the primary terminal, and the Ordze Transit Centre as a secondary location. Local transit services provide access to all parts of Sherwood Park with one transfer, at most. Local services provide access for many members of the community who do not drive, including youth, seniors, and persons with disabilities.

The Priority Based Budgeting programs under the Local Transit core function are:

- Local Transit Peak Service
- Local Transit Midday Service
- Local Transit Evening Service
- Local Transit Weekend Service

MOBILITY BUS

Mobility Bus is a door-to-door service for people with mobility limitations that is provided County wide. Mobility Bus provides critical access for persons whose limitations prevent them from using the fixed-route services.

The Priority Based Budget programs under the Mobility Bus core function are:

- Mobility Bus Local
- Mobility Bus Rural
- Mobility Bus Edmonton/Sherwood Park

SPECIAL EVENTS

Special events services provide access to annual festivals and events throughout the region, including Heritage Days, Canada Day, New Year's Eve, and other community events. The Priority Based Budgeting programs under the Special Events core function are:

- External Public Events Transit
- Internal Bus Rentals Charter Transit

2022 - 2025 FORECAST

COVID-19 has negatively impacted ridership for two years and will continue to do so. It is unknown for how long, or if, ridership will return to pre-COVID-19 levels.

The budget forecast for this core function is strongly impacted by expected increasing fuel price increases.

The U-PASS program was renewed in August 2021 for four years. This program provides a reliable source of revenue for Strathcona County Transit.

Continued work on the Arc project will provide an account-based electronic fare payment system.

On Demand Transit was approved by Council in July 2021 and will be implemented in 2022. On Demand Transit replaces the five local routes currently operating during evenings and weekends with a shared-ride demand-responsive service. The purpose is to meet the mobility needs of County residents, while also improving the efficiency of service.

DEPARTMENT ANNUAL CAPITAL IMPROVEMENTS

ANNUAL BUS PAD ADDITIONS PROGRAM (AUTO 2092)

Currently throughout Sherwood Park, many bus stops are simply a sign on a boulevard of grass. In order to become a safe and accessible system, it is imperative that concrete bus pads be installed to provide a structured boarding and alighting platform for passengers. Without an acceleration in installing these pads Strathcona County Transit will not be a fully accessible system for many years and passengers with mobility challenges will continue to be limited in using the service.

DEPARTMENT STRATEGIC INITATIVES

ARC (FORMERLY SMART FARE) / SMART BUS TECHNOLOGY IMPLEMENTATION (00313-SCT)

Strathcona County Transit is a partner in the regional Smart Bus/Arc project that includes Edmonton, St. Albert, Leduc, Fort Saskatchewan, Spruce Grove, and Beaumont. The Smart Bus technology was fully functional in 2021 and provides customers with a variety of features including:

- Automated stop announcements
- Automated vehicle monitoring to show real time location of your bus
- GPS location services

Furthermore, the Smart Bus technology contains the necessary telecommunications and infrastructure to handle the Arc system. The U-PASS program started using the Arc system in September 2021. The remainder of the program is scheduled to roll out in multiple phases with the following features:

- An account-based system that enables customers to purchase transit fares that can be used immediately to pay for a ride
- An ability to manage accounts using web-based applications, through a call centre or at Smart Fare vending machines
- An ability to purchase fare products at hundreds of regional retailers

ON DEMAND TRANSIT (INIT 182)

On Demand Transit will provide a shared-ride demand-responsive service within Sherwood Park during evenings and weekends. This type of service will better meet the mobility needs of County residents who require flexible, on-demand transportation, as well as provide opportunities to be more operationally efficient. The benefits of On Demand Transit include:

- On Demand service will reduce customer wait times and deliver customers faster to their end destination locally within Sherwood Park during off peak evenings and weekends.
- Fixed route only services the stops along one route, On Demand offers a service that picks up and drops off at any local stop and reduces the need to transfer.
- Our transit resources will be more efficient. If there are no customer trips, the bus will not move.
- The environmental impact will be less as emissions will be reduced. Shorter trips reduce greenhouse gases. Reducing Strathcona County's carbon footprint preserves our community. Reducing our carbon footprint also saves costs without compromising service quality.
