In consideration of Strathcona County renting me the equipment identified on Page 1 of this Form (the "Equipment"), accepting my group booking to which the rental relates, and permitting my group to access and utilize the Strathcona Wilderness Centre property and facilities, I, the group organizer named below, agree as follows:

Equipment Rental

1. I acknowledge that I have rented the Equipment from Strathcona County, and I accept, and acknowledge receipt of, this Equipment.
2. I agree to return all Equipment, in a clean and undamaged condition, by no later than the "Due Back By" time noted on Page 1 of this Form on the date set out on Page 1 of this Form.
3. Although a portion of the Equipment will be utilized by group members other than myself, I accept full responsibility for the Equipment and I agree to pay Strathcona County for any damage to the Equipment that occurs during the period of the rental, other than ordinary wear and tear, and to pay Strathcona County the full retail value of any Equipment that is not returned by the date and time agreed under Section 2 or that is returned in an irreparably damaged condition, as determined by Strathcona County.
4. I will not use, and will instruct all members of my group not to use, any Equipment until I/they have received instruction on its use and fully understand its use and function.

Waiver Requirement and Indemnity

I confirm that I have obtained, and provided to Strathcona County, a signed Adult Waiver (Group Booking) or Minor Waiver (Group Booking), as applicable, in the form provided to me by Strathcona County, for myself and every member of my group that will be accessing the Strathcona Wilderness Centre property and facilities in connection with my group booking.

I acknowledge that providing a signed waiver for every member of my group, as contemplated above, is a pre-condition to my rental of the Equipment and my group's access to, and use of, the Strathcona Wilderness Centre property and facilities.

I agree that, in the event that a person accesses or utilizes the Strathcona Wilderness Centre property or facilities pursuant to, or in connection with, my group booking, and I have not, prior to this access or use, obtained a signed Adult Waiver (Group Booking) or Minor Waiver (Group Booking), as applicable, in the form provided to me by Strathcona County, from that person, and provided the same to Strathcona County, **I SHALL HOLD HARMLESS AND INDEMNIFY STRATHCONA COUNTY, AND ITS COUNCILLORS, OFFICERS, EMPLOYEES, AGENTS, REPRESENTATIVES, SUCCESSORS AND ASSIGNS, FROM AND AGAINST ANY ACTIONS, CLAIMS, LIABILITIES, EXPENSES AND COSTS (INCLUDING, WITHOUT RESTRICTION, LEGAL COSTS ON A SOLICITOR-AND-HIS-OWN-CLIENT FULL INDEMNITY BASIS) THAT MAY BE MADE AGAINST, OR INCURRED BY, THEM, INCLUDING AS A RESULT OF ANY PROPERTY DAMAGE, PERSONAL INJURY OR EXPENSE TO THE PERSON IN QUESTION OR ANY THIRD PARTY, RESULTING FROM OR RELATING TO THAT PERSON'S ACCESS TO, AND USE OF, THE STRATHCONA WILDERNESS CENTRE AND ANY ASSOCIATED PROPERTY AND FACILITIES.**

General

This Agreement will be effective and binding upon myself, my heirs, next of kin, executors, administrators and assigns.

This Agreement and any rights, duties and obligations as between myself and Strathcona County is governed by the laws of the Province of Alberta, and that any litigation will be brought solely within the courts of the Province of Alberta.
