Pre-application meeting (MDP and LUB Amendments, ASPs & ACPs and Amendments, Conceptual Schemes) Advising and assisting applicants in the preparation of applications for submission	
Initial pre-application meeting	\$500.00**
Subsequent pre-application meeting(s)	\$500.00/meeting**

Country Residential Policy Area Rural Road Levy	\$ 23 498.00/lot (subject to change)***

Additional information/interpretations:

- Application fees may be refunded upon written request as follows:
 - 90% prior to application circulation
 - 20% after circulation but prior to preparation of Administration's report.
 - No refund after the Administrative report has been prepared.
- Advertising fees may be refunded upon written request as follows:
 - 100% if request is received prior to advertising.
 - No refund if advertising has been completed.
- Where there is a dispute over interpretation of the fee or refund, a written request can be made to the Director of Planning and Development Services for clarification.
- For application/endorsement fees that are based on a per lot system, the remnant parcel and all public lots (eg. MR, ER, PUL) shall not be considered a lot to which the fees shall apply, except where a public lot is the subject of the application.
- For application/endorsement fees that are based on a per lot system, where there is no remnant parcel, the lot fee shall be calculated based on the total number of new lots created minus one lot (to account for the original lot). Excluding boundary adjustments and lot consolidations.
- An application is not considered complete and will not be processed until all fees are paid
