RESPONSIBLE DOG OWNERSHIP BYLAW (37-2017)

## A new approach from your feedback



The Responsible Dog Ownership Bylaw focuses on owner responsibilities through incentives and enforcement.

All dogs residing in Strathcona County are required to have a dog licence, renewable each year.

# Dog licence fees and incentives

The licence year runs from April 1 - March 31, annually. Owners have 30 days to license their new dog. If you qualify for free licence year(s), you must still register your dog.

First licence year for your dog	FREE
Licence year following electronic identification microchipping for a dog <sup>1</sup>	FREE
Licence year following owner and dog successfully completing obedience training approved by Strathcona County <sup>1</sup>	FREE
Two licensing years following both microchipping and approved training in the same licensing year.	FREE
Certified assistance (guide) dog	FREE
Rescue dog (in temporary care of a rescue organization)	FREE
Puppy not older than six months	FREE
Spayed or neutered yearly fee	\$35
Non-spayed or non-neutered yearly fee	\$70
Over-limit permit yearly fee  • An over-limit permit is required for more than three dogs living on property five acres or less in size; or for more than five dogs living on property larger than five acres in size.  Please note: first time over-limit permits must be applied for in-person at the Enforcement Services office	\$70
Dangerous dog yearly fee - if deemed a dangerous dog by Strathcona County	\$750
Replacement dog tag	\$5

return your lost dog to you. Licence fees help pay for care and shelter for lost dogs.

### Keeping the peace

If your dog is whining, barking or howling – it's probably a concern to people around you. It's up to you to make sure your dog does not disturb other people. It's also important to clean up after your dog.

#### Fines increase with each subsequent offence.

Fines include, but are not limited to:

Dog without a valid licence	\$250
Dog at large	\$150
Unsecured dog in vehicle	\$100
Dog in distress	\$250
Dog barking excessively or failure to remove dog waste	\$150

#### It is the dog owner's responsibility to ensure:

- · Dogs are wearing a valid Strathcona County licence tag
- Dogs are under the owner's control
- Dog's waste is picked up

#### Off-leash areas

Dog owners are welcome to take their dogs to the **Deermound** Off-Leash Park, located south of Sherwood Park on Township Road 522, just west of Highway 21.

There are also seasonal neighbourhood dog off-leash sites located throughout Strathcona County during the winter months (November – March) and summer months (May- August). Visit: www.strathcona.ca/dogsinparks for locations and details.
