Delegate some or all aspects of decision making to citizens and stakeholders.



# **Project Purpose**

Range Roads 231 and 232 are vital connections to some of Strathcona County's residential and rural areas.

These roads will require upgrades as growth and development take place. The study will recommend upgrades to improve safety and traffic flow, and support future growth.











# **Study Outcomes**

This study will identify the long-term requirements for:

- Number of travel lanes
- Intersection improvements
- Speed limits
- Multi-use trails
- Drainage requirements
- Right-of-way impacts

Construction of the recommended improvements are unknown at this time, and are subject to priority lists and the municipal budget.

The project team has begun gathering input through an online survey, doorto-door visits, and kitchen table meetings in the community.

- Posted speed limit is too high
- Speeding
- Sightline issues
- Noise (particularly from large trucks and motorcycles)
- Lack of sidewalks or trails
- Narrow roadside shoulders
- Congestion at the Christian Academy, before / after school
- Localized flooding







#### What We Have Heard: Wants




